### Gender violence

#### What is indecent act by compulsion?



The act of molesting a person through violence or threats

#### Case of forced harassment



01 When a co-worker massages an employee's shoulder or touches the employee's body.



02 In cases where a love shot is made by taking advantage of the superior/ subordinate relationship at work.



O3 A stranger touches your body, adheres to the body such as a genital, or continues to contact certain parts of the body (breasts, genitals, buttocks, etc.) in a crowded place.

#### What is rape?



Forcibly having sexual intercourse with a person by making it difficult for them to resist through violence or threats

#### Rape case



01 When a couple is forced to have sexual intercourse by assault or threats even though the other partner does not want to.



O2 When the victim is forced to have sexual intercourse by threatening to inform others of the other person's weaknesses.



O3 (Quasi-rape) Rape while unconscious or asleep under the influence of alcohol or medicine.

#### What is Criminal Voyeurism?



The act of photographing the body (buttocks, chest, legs, etc.) against the will of the subject using a camera, etc.

#### Examples of shooting using cameras, etc.



**01** Secretly filming the body, such as legs or buttocks, in a subway, bus, or elevator.



**02** When one of the lovers films a sexual intercourse against the other's will.

# What is an obscene act using communication media?



An act of sending sexually humiliating or disgusting words, writings, pictures, videos, etc. through phone, computer, etc.

## Case of pornography using communication media



O1 When sending obscene words, photos, or videos through messengers or SNS such as KakaoTalk, Instagram, or Twitter.



O2 Saying obscene words while talking on a voice call

#### What is a stalking crime?



Approaching or following the victim against the victim's will without justifiable reason or causing anxiety or fear in the other person by repeatedly calling or texting.

#### **Stalking Crime Cases**



01 Waiting in front of the victim's residence until the victim returns home.



O2 Repeatedly sending phone calls, text messages, or emails to the victim without justifiable reason.



O3 Sending gifts such as flowers and cakes to the workplace of an ex-lover.



04 Intentionally creating noise between apartment floor neighbors repeatedly for several months.

### What is dating violence?



Acts such as assault, threats, and property damage that occur between a man and a woman who are or have been in a relationship.

#### Case of dating violence



O1 Assaulting the victim in a romantic relationship because he or she does not like his or her behavior.



Damaging the victim's cell phone by throwing it on the floor during an argument in a romantic relationship.



O3 Threatening to an ex-lover by saying, 'If you don't meet me, I will kill you.'

#### What is domestic violence?



It refers to acts of physical, emotional, sexual, and economic violence that occur between family members.

#### Cases of domestic violence crimes

(only cases subject to criminal punishment are listed)



O1 Assaulting your spouse or confining him or her so that he or she cannot leave the house.



O2 Throwing and breaking objects or threatening with a weapon.



O3 Starving a family member who cannot afford to eat or not taking them to the hospital.

### Are you hesitant to report it?

If you hesitate because of your illegal alien status

#### Notification obligation exemption system

Regarding illegal immigrants who are victims of domestic violence crimes such as assault, injury, and threats System for exemption from notification to immigration office.

\*However, some crimes such as home invasion and damage are excluded from the notification obligation.

### If you hesitate for fear of being disadvantaged in acquiring nationality

If you meet the requirements for naturalization under the Nationality Act, naturalization is permitted even if your spouse objects.

You can apply for a simple naturalization permit even if you are divorced, if you are not responsible for the reason for the divorce.
